Selectmen Meeting Minutes May 11, 2021

1. Approval of the minutes from 5/04/21 Selectmen Meeting. Justin moved and Oren seconded the motion to approve the minutes of 5/04/21 Selectmen Meeting as written. The motion carried unanimously.

2. Public Input

Diane questioned how the check for the project needs to be made out. Mr. Hammer said to make the check out to him as President of the Historical Society.
- f. The Town Clerk's office staff came into the Selectmen's meeting to discuss a system to double check each other's work. This will be done from now on. Also, the Selectmen are putting together a policy on making deposits.
- g. Discussion regarding Pete and Gerry's. The Selectmen reviewed the spreadsheet provided from Pete and Gerry's regarding the hauling of trash. A representative from Pete and Gerry's will be here next meeting to discuss further.
